The Regular Village Board meeting held on February 8, 2024, was called to order at 10:00 a.m. by Village President Dave Alden.

Chief Thiex gave the January Police Report. The Department has been increasing coverage in the Towns of Oakland & Meenon. Citations were down for the month. The Department has not heard from anyone official on the Governor's Fishing Opener; however, the Village Department will be able to handle the coverage within the Village.

After discussion with Public Works Director Jim Jaskolka, it was decided that Well House #1 at Crooked Lake Park should be insulated and have an exterior face-lift. The cost for the amendment is \$5,500 which can be included in the grant expenses.
